

Savvy Dee's Dachshunds Breeder Guarantee

Savvy Dee's guarantees that the puppy/dog is in good physical health and has no visible signs of hereditary defects on this day of purchase. Buyers have 72 hours to take the puppy/dog to a vet of your choice. It should be checked over at that time to buyer's satisfaction for imperfections, disease, and health of the dog. Failure to take puppy/dog to veterinarian by said 72 hours ends Savvy Dee's guarantee. Savvy Dee's should be contacted with the health check. If a dog is found to be unfit for purchase due to illness, disease, or congenital disorder, Savvy Dee's must be informed IMMEDIATELY. To get a replacement, the puppy must be returned to Savvy Dee's with papers, or NO COMPENSATION will be given. Buyer pays ALL shipping costs involved in obtaining a replacement puppy. Savvy Dee's will not be responsible for ANY veterinarian fees or costs. Buyer acknowledges the health agreement and agrees to have puppy/dog checked or accept dog as is. _____

If the puppy passes within one year of ownership, a necropsy has to be done to determine cause of death in order to receive replacement puppy. Puppy will be replaced if the cause of death was an inherited congenital defect. _____

Further guarantee is limited to the development of any serious, life threatening, congenital, or hereditary defects within 1 year, and is limited to a replacement of the puppy/dog of same color/gender, with the next available litter. Written notification directly to Savvy Dee's from your veterinarian is required. Savvy Dee's will not be responsible for ANY Veterinarian fees or costs. We reserve the right to have the puppy/dog returned for examination through our veterinarian. _____

There is no guarantee or warranty that the buyer will be able to show or breed the dog, regardless of show or breeding potentials. _____

I agree to not sell this dog or any puppies from this dog to a commercial breeder, broker, pet store, or auction. If you can no longer keep said dog, you must contact Savvy Dee's and give Savvy Dee's first chance to purchase. _____

I, the buyer, have read this contract and understand fully the contents thereof and acknowledge receipt of it. I also agree that any legal dispute will be settled by the laws of White County Arkansas and in a court in White County Arkansas. _____

Do Not take your puppy to high traffic public places and put it on the ground until after the 3rd vaccination. Try to pick a place most people would not stop at. This protects your puppy from Parvo. _____

If a deposit is placed on a dog, I understand it is a NON REFUNDABLE DEPOSIT, and the remaining balance is due before the dog is picked up or shipment is made. _____
